

The retrofit challenge for social housing

Social housing needs to achieve an Energy Performance Certificate (EPC rating) of C by 2030.

Across West Yorkshire alone there are over 181,000 social housing homes. Of these, using BEIS postcode data, it is estimated there are 83,902 properties below EPC C, as summarised in table 1 right. In simple terms, investment will be required to c.18,000 per annum to complete the works by 2030. This assessment can broadly be replicated in other areas.

Assessing the scale of investment is dependent on the exact scope of the work and how far social housing providers will incorporate Decency works as part of the overall delivery plan. The Social Housing Decarbonisation Fund assumed:

- EPC D £20k for solid Wall properties and £10k for Cavity Wall
- EPC E £24k for solid Wall properties and £15k for Cavity Wall
- EPC F/G £32k for solid Wall properties and £20k for Cavity Wall

Using this as a broad basis the table right shows the possible scale of investment, based on a £spend/home of £10,000 and £20,000 respectively. It only considers the c. 84,000 homes needed to be upgraded to achieve level C and make no allowance for any additional dwellings social housing providers may choose to include as part of the upgrade programme. Similarly, it assumes any delivery programme will commence in 2025, giving a 5 year window to meet the 2030 deadline.

EN:hancing capacity

The scale of work required to meet the 2030 Challenge will entail fresh approaches to increase material and delivery capacity, through upskilling, re-skilling and encouraging new entrants into the 'green' contruction sector.

It is estimated the industry needs to increase its workforce by 350,000 FTE workers over the next decade to deliver the volume of work needed to reach Net Zero 2050. This means the sector needs to prioritise new recruitment from outside the sector, undertake retraining and ensure productivity gains to have a realistic chance to meet the decarbonisation goals.


The chart below shows the employment requirement for

delivering decarbonisation in buildings. Furthermore, a wide range of roles are required across the construction sector from a variety of operative professions, technical and professional roles, manufacturing and support sector roles. Generally, each role requires an employment and skills pathway and accredited qualifications.

In West Yorkshire, the prospective $\pounds 1.6$ bn retrofit investment by 2030 presents a golden opportunity to generate resources for training, skill development and apprenticeships. This can be a catalyst for new green jobs and inclusive growth in the region and enable social housing tenants to make up some of the lost ground in economic performance. EN is in dialogue with the West

Yorkshire Combined Authority, West Yorkshire Housing Partnership and the Consortium of FE Colleges to identify and introduce courses and training that can help meet that demand. This is likely to comprise a range of options including apprencticeships, T-levels, re-training and short courses that can attract local people and school leavers.

Construction Leadership Council The chart below is from CLC's (Construction Leadership Council) latest comprehensive research using the Climate Change Committee's data to define a skills routemap for the UK construction industry, which identifies the roles and expertise teams need to meet the requirements for the UK, Wales and Scotland.

Efficiency North's specialist procurement arm EN:Procure is in the process of renewing its framework offer. EN:Procure already has a significant capacity through its existing Installers framework, along with Retrofit DPS's in place for consultants and contractors, comprising over 100 PAS2030 accredited - mainly SME - contractors, growing month on month. The new framework structure will further enhance this capacity, by including specific Retrofit lots which will add main contractors able to deliver large scale decarbonisation projects at pace. The framework will enable Direct Selection as well as Mini-Comps, allowing for faster procurement.

Addressing the skills shortage

Social Value is at the heart of Efficiency North's activities.We strive to improve social mobility and regenerate communities by supporting local projects, creating employment opportunities and delivering training and apprenticeships for local people. Efficiency North is therefore ambitious in seeking to support the social housing sector, not only through our procurement and delivery expertise, but also by helping deliver training provision to benefit our members and their residents.

Social housing providers serve communities where there are significant low levels of skills and worklessness. Many have Employability teams to support their resident base, providing a range of training provision and support engaging with their communities and stakeholders in innovative ways. The retrofit agenda for social housing provides significant opportunities for social housing providers to directly influence the FE training provision through its procurement requirements in contracts to both upskill and develop new training pathways for new entrants to the construction sector.

To meet this challenge, Efficiency North is currently developing a coalition of the key stakeholders in the West Yorkshire region to develop training pathways that will not only upskill the current workforce in the required retrofit skills but entice new entrants into the sector to meet the new skills that retrofit will create.

Through dialogue with leading local representative bodies (West Yorkshire Combined Authority, West Yorkshire Housing Partnership and West Yorkshire Consortium of Colleges) and leading construction industry bodies, we are aiming to establish a collaborative approach to maximise the significant investment retrofit will bring, enabling the construction sector supply chain to invest in training and employing skilled staff to deliver the work.

Opportunties include:

- Developing training pathways to, in particular support residents from social housing communities prepare for the world of work supported by the social housing provider employment teams and other locally based providers.
- Local FE provision to provide a range of construction related courses that support the variety of retrofit skills for both new entrants and shorter upskilling courses to train the existing and new entrants through career changers into the sector.
- Up-skilling/re-skilling of existing labour
- T-levels?

Adopting this collaborative approach will enable a focussed approach in promoting career opportunties in the Green sector, a sector that is only likely to expand as requirements move beyond meeting EPC-C to achieving Net Zero by 2050. Retrofit has become the main focus of schemes and being able to deliver the correct advice is vital to our schemes and clients. I would recommend this course to those who need the understanding of the new standards and how PAS works.

Recent Retrofit and Decarbonisation projects

SHDF Wave 1: Incommunities, Bradford



Incommunities were successful in the SHDF Wave I Funding bid through the consortium led by West Yorkshire Combined Authority to deliver a £3m retrofit programme for 102 homes.

Two thirds of the funding came from BEIS. The 12-month project is aligned with Incommunities' planned programme for boiler upgrades and roofing replacement.

Specialist contractor, Sustainable Building Services, were procured through EN:Procure's framework on a Measured Term Contract in a turnkey role, providing the potential to roll on for SHDF Wave 2 funding. The scheme involves work in the Wyke area of Bradford to improve the energy performance of the homes through wall and loft insulation, new windows and doors, moving properties from bands D and E to band C EPC rating.



The cost-of-living crisis means people living in fuel poverty will be feeling the strain on their finances. It is vital that we find ways to help cut costs they may already be facing, not just now but for years to come. I'm delighted to hear of the progress being made by our partners as part of the Social Housing Decarbonisation Fund Programme scheme. Not only will this project make homes warmer, but it will also cut carbon emissions and help reduce heating bills.

SHDF Wave 1: Together Housing Group, Calderdale

Together Housing Group's External Wall Insulation scheme for 68 low rise flats in Calderdale began on site in August 2022 and completed in March 2023.

The £1.9m scheme was part funded with £774k received through the West Yorkshire Combined Authority consortium's successful bid to the SDHF (Social Housing Decarbonisation Fund) Wave 1.

The specialist EWI contractor, Sustainable Building Services, was procured via EN:Procure's framework on a Measured Term Contract in a turnkey role, providing the potential to roll on for SHDF Wave 2 funding.

The scheme also included the replacement of gas heating systems with air source heat pumps.

This is a very successful scheme, which has delivered improvements to the energy performance of some of Together Housing Group's poorest performing housing stock, and tangible benefits for tenants now living in warmer, more comfortable and more affordable homes.





Together Housing has been pleased to work with Efficiency North to deliver our SHDF Wave 1 project. Working together, we have procured a specialist EWI contractor to undertake a challenging SDHF Wave 1 retrofit project. EN:Procure's procurement process has achieved value for money whilst also ensuring that quality standards are high and successful delivery on site. We are now seeing the benefit of this in the successful on site delivery of the project.

LAD3 & HUG1: City of York Council, Craven District Council, Harrogate Borough Council & Selby District Council



A consortium of local authorities led by City of York Council (COYC) delivered LAD3 and HUG I funded measures to 213 privately owned homes.

EN:Procure led the development of the commercial approach to the turnkey delivery of the £3.5m scheme. Contractor EON Energy Solutions Ltd was appointed via EN:Procure's framework on a Measured Term Contract in a turnkey role, providing the potential to roll on for SHDF Wave 2 funding. The contract included mechanisms for marketing and private householder engagement as well as providing the full specification for the measures.

A second contract with City of York Council supports delivery of SHDF Wave I works to 28 homes.

External Wall Insulation (EWI) upskilling





A short unaccredited course which upskills plasterers with multiple skills required for rendering is being co-designed by Leeds College of Building, sector trade bodies, INCA, NIA and leading companies.

Funded by the Department for Education through West Yorkshire Consortium of Colleges (WYCC), this is the first such course to be provided in Yorkshire.

Following delivery of this course, Leeds College of Building will develop a Level 3 qualification in Insulation and Building Treatment.


